In accordance with the provisions of Section 26 of the Gorkhaland Territorial Administration Act, 2011 (West Bengal Act XX of 2011) and in continuation of No.1662/AR&AH/4A-66/12 dated 27.08.12, the Governor is pleased hereby to issue the following directions :

1. The items of work, offices/institutions as per the Schedule below stand transferred to the Gorkhaland Territorial Administration with immediate effect.
2. Services of all officers and staff working in connection with the items of work, as above, in the region as stated in Section 2 clause (o) of the Act in the district of Darjeeling, are placed at the disposal of the Executive Sabha on deputation with immediate effect. 3.
