Darjeeling Irrigation Division along with its full complements including services of all officers and staff have already been transferred on deputation from the administrative control of North Bengal Flood Control Commission under Irrigation & Waterways Directorate to that of the then Darjeeling Gorkha Hill Council (DGHC) on 19.06.1989 vide his Department's Notification no. 68 dated 08.06.1989 communicated vide Memo No. 1335(25)-IE dated 08.06.1989 read with Irrigation & Waterways Department no. 518-IA dated 12.07.1989.

Now, in pursuance of the provisions under section 26, sub-section (ix) of Gorkhaland Territorial Administration Act, 2011 (West Bengal Act XX of 2011) read with section 60(1), 60(2) and 60(3) of the said Act, the Governor is further pleased to hereby issue the following direction:

- (1) The items of work, offices/institutions as per '**Schedule A**' below in the region as stated in Section 2, clause (O) of the Act, **now stands transferred to the Gorkhaland Territorial Administration (GTA), with immediate effect.**
- (2) Services of all officers and staff, as detailed in '**Schedule B**' below, working in items of work, offices/institutions, mentioned in the '**Schedule A**', in the aforesaid region in the district of Darjeeling are placed at the disposal of the Gorkhaland Territorial Administration on deputation with immediate effect.
