NOTICE

In congruence with Notification No. H&FW/118/20 Dated 16th March 2020 of the Department of Health & Family Welfare, Govt. of West Bengal and pursuant to the meeting held in Gorkhaland Territorial Administration (GTA) Office, Darjeeling today i.e 18th March 2020 with representatives of Motor Association, Porters' Association and Hotel Owners' Association, it is stated that tourists will be restricted in the GTA area in Darjeeling District on and from 19th March 2020 till 15th April 2020. This is being done to contain the spread of COVID-19.

It is further noted that clubs, or, institutions within the district are to refrain from holding any event which requires large gathering of people and maintain the "social distancing" aimed towards containment and management of spread of COVID-19.

Any resident of the district, or, any other person presently in the district, with a history of travel, in the last 16 days to a country, or, area from where COVID-19 has been reported, must report to the nearest Govt. hospital or call at 1800 313 444 222/033 2341 2600, for necessary action from the Health & Family Welfare Department.

Any resident of the district, or, any other person presently in the district, with a history of travel to a country or area from where COVID-19 has been reported in the last 16 days, but who do not have any symptoms of cough, fever or difficulty in breathing, should isolate themselves at home, or as advised by health professionals. Such persons must avoid contact with any person, including family members for 14 days from the date of arrival from such country, or, area.

Further, it is to be noted that staff of all Govt. department will be at disposal of district administration for discharging the duty of containment measures.
