

1.	11.03.2019	<p>Whereas General Election to Lok Sabha, 2019 at Darjeeling district will be held on 18/04/2019 as communicated vide press note No. ECI/PN/23/2019 Dated: 10th March, 2019 by election Commission of India;</p> <p>And</p> <p>Whereas as per instruction of Election Commission of India vide no. 464/INST/2009/EPS dated 01.09.2009 read with No. 1068(24)-Home/Elec dated 05.03.2019 of the Additional Chief Electoral Officer, West Bengal carrying of licenced arms should be banned till the declaration of results for ensuring free and fair election;</p> <p>Considered. In exercise of the power conferred upon me u/s 144(2) of the Code of Criminal Procedure, 1973 I Smt. Joyoshi Dasgupta, District Magistrate, Darjeeling District do hereby ban carrying of licenced arms and ammunities in the district of Darjeeling till the declaration of results.</p> <p>Persons/Agencies wishing for exemption may apply to the Screening Committee comprising District Magistrate, Darjeeling & Superintendent of Police, Darjeeling in case of Darjeeling Police District area and Commissioner of Police (Admn.) and Joint/Additional Commissioner of Police (Admn.) in case of Siliguri Metropolitan Police Commissionerate area.</p> <p>Unlicensed Arms are illegal and shall be seized by concerned authorities.
