NOTIFICATION

In pursuance of the provision of the Section 26 of the Gorkhaland Territorial Administration Act 2011 (WB Act XX of 2011) read with Section 60 ibid, the Governor is pleased hereby to issue the following directions:-

1. Constitution of a Committee for the welfare of the Scheduled Castes and Scheduled Tribes within the territorial jurisdiction of Gorkhaland Territorial Administration (GTA) as notified in the said Act with the following Members:
 - (i) Member of GTA Sabha nominated by the Chief Executive of GTA as Chairperson.
 - (ii) Principal Secretary to GTA or any Officer appointed by him/ her.
 - (iii) One Member of GTA Sabha representing ST community of GTA area.
 - (iv) One Member of GTA Sabha representing SC community of GTA area.
 - (v) MLA/ MLAs belonging to SC & ST communities.
 - (vi) DWO whose service is being placed with GTA.
 - (vii) District Manager whose service is being placed with GTA – Member Secretary.

Powers and functions of the Committee in relation to the welfare of Scheduled Castes and Scheduled Tribes through various schemes of West Bengal Scheduled Castes and Scheduled Tribes Development & Finance Corporation (WBCSTDFC) shall be determined and finalised by the GTA.

2. The existing District Branch Office of the WBCSTDFC located at Darjeeling is hereby transferred to GTA with the items of work as mentioned in **Schedule A** with immediate effect.
3. Services of all Officers and staff including the deputation post of District Manager presently attached with the aforesaid District Branch Office as shown in **Schedule B** are hereby placed at the disposal of GTA on deputation with immediate effect. While Terms of deputation of the post of District Manager shall be determined by the State Government, the same of the other officers and staff of the WBCSTDFC shall be fixed by the WBCSTDFC in consultation with the State Government in due course.
