**NOTIFICATION**

In cancellation of this department's Notification No.2989-BCW/5E-42/12 dt. 24.08.2012 and In pursuance of the provisions under Section 26 of THE GORKHALAND TERRITORIAL ADMINISTRATION ACT, 2011 (West Bengal Act XX of 2011) read with Section 60(1) And 60(2) of the said Act, the Governor is pleased hereby to issue the following directions:

1. The items of work and offices as per Schedule -A below, in the region as stated in Section 2 clause (O) of the Act stand transferred to the Gorkhaland Territorial Administration with immediate effect.
2. Services of all officers and staff, as detailed in Schedule-B below, working in items of work and offices mentioned in the Schedule-A, in the aforesaid region in the district of Darjeeling are placed at the disposal of the Gorkhaland Territorial Administration on deputation with immediate effect.
3. The work relating to statutory function i.e. West Bengal Schedule Castes and Schedule Tribes (Reservation of vacancies in services & Posts) Act, 1976, Identification Act, 1994, Prevention of Atrocity Act, 1989 and Protection of Civil Rights Act, 1955 and Rules framed thereto will continue to be performed by the State Government Officers as before.
