In pursuance of provisions under Section 26 of the Gorkhaland Territorial Administration Act, 2011 (West Bengal Act XX of 2011) read with Section 60(1) and 60(2) of the said Act, the Governor is pleased hereby to issue the following direction :

1. The items of work, offices/institutions as per Schedule-A below in the region as stated in Section 2 Clause (O) of the Act stand transferred to the Gorkhaland Territorial Administration with immediate effect.
2. RESOLUTION

The Ministry of Agriculture, Government of India has sanctioned setting up of a Fish Farmers' Development Agency, in the district of Darjeeling in the State to start functioning with immediate effect during the current financial year i.e. 1986-87 under Centrally Sponsored Scheme on Development of Aquaculture.

2. The Governor is accordingly pleased to set up the Darjeeling Fish Farmers' Development Agency (hereinafter referred to as the Agency) to provide the mechanism to coordinate the role of various agencies connected with fish culture and integrate various activities in this field such as training persons in modern techniques of fish farming, arranging funds to enable them to improve the water resources and take up pisciculture and organising necessary supplies and services to them including marketing.

3. The Governor is also pleased to constitute a Managing Committee for the said Agency with the following members :-

- i) Collector, Darjeeling : Chairman
- ii) Additional District Magistrate, Darjeeling (Land Reforms) : Vice Chairman
- iii) Two Executive Engineer of the Darjeeling district to be nominated by the Collector of the district in consultation with the Chief Executive Officer of the Agency : Member
- iv) Assistant Registrar of Cooperative Societies, Darjeeling : Member
- v) District Panchayat Officer, Darjeeling : Member
- vi) District Fishery Officer, Darjeeling : Member
- vii) A representative of each of the Banks participating in the Project in the district : Members
- viii) Two representative of the Fish farmers to be nominated by the Collector of the district in consultation with the Chief Executive Officer of the Agency : Members
- ix) Convenor of the District Level Coordination Committee of the Financial Institutions provided he is not already included as a representative of any of the participating banks : Member

b) set up a Standing Committee (consisting of not more than five members one of whom shall be the Chief Executive Officer) and entrust the Committee with specific powers concerning financial and executive matters;

c) delegate sufficient authority and powers to the Chief Executive Officer concerning sanction of funds, appointments and other service and executive matters.

5. The Committee will meet as often as is necessary, but atleast once in two months. Notices for the meetings should be issued atleast seven days before the meeting. The Chairman and in his absence the Vice-Chairman will preside over the meeting of the Managing Committee. In the absence of both the Chairman and the Vice-Chairman, members present shall elect the President of the meeting from amongst themselves barring the Chief Executive Officer. Necessary notes on subjects for the decision of the Managing Committee will be provided to the Chief Executive Officer. Copies of the proceedings of every meeting shall be forwarded to the Secretary, Fisheries Department, West Bengal and the Director of Fisheries, West Bengal.

7. One-third of the members present rounded off to the next higher figure, where necessary, will form the quorum for the meeting of the Managing Committee.

8. The Chief Executive Officer, will carry out the decisions of the Managing Committee and report to it the progress made in such manner as may be prescribed by the Managing Committee.

9. The Agency will be under the overall direction of the Director of Fisheries, West Bengal.

10. The Government in the Fisheries Department will have the power in exceptional cases to cancel or modify any decision of the Managing Committee in consultation with the Director of Fisheries, West Bengal.
