**NOTIFICATION**

In pursuance of the provisions under Section 26 of the Gorkhaland Territorial Administration Act, 2011 (West Bengal Act XX of 2011) read with Section 60(1) and 60(2) of the said Act, the Governor is pleased hereby to issue the following direction :


