**NOTIFICATION**

WHEREAS the Gorkhaland Territorial Act, 2011 has been promulgated vide Notification No.331-L dtd. 12.03.2012.

AND WHEREAS an administrative set up is to be constituted for the Gorkhaland Territorial Administration.

Therefore, in terms of Section 51 to Section 54 of the GTA Act, 2011, the Governor has been pleased to transfer Sub-Regional Tourist Office at 1, Nehru Road, Darjeeling-734 191 under the Directorate of Tourism, Govt. of West Bengal along with its existing set up to the Control of the GTA subject to fulfillment of conditions as laid down under Section 60 of the GTA Act, 2011 of the Sub-Regional Tourist Office, Darjeeling with immediate effect.


