**ENGAGEMENT NOTICE FOR ASHA**

In pursuance of the ORDER vide memo no. HFW/NRHM-652/12/1162 dtd. 12.03.2018 Accredited Social Health Activist (ASHA) will be engaged in different Villages/locality of Mirik Development Block noted in the annexed list.

**Eligibility:**

1. The candidate should be married/divorced or widowed women.
2. The Candidate should be a resident of the same village/Locality for which she will be selected (Noted in the list).
3. She should be within the age group of 30-40 years on the date of notification. In case of SC and ST candidates, the lower age limit is relaxed to 22 years.
4. She should be Madhyamik passed or failed. Candidates who are Madhyamik pass or possessing higher qualification are also eligible. However, in case of candidates possessing higher qualification, only marks obtained in Madhyamik or Equivalent examination will be considered.

**Self-Attested Xerox Copies of Documents to be submitted/ Originals also shown mandatorily by the applicant while submitting Application:**

1. The proof of residence (Voters' Identity Card or Ration Card)
2. Mark sheet of Madhyamik or Equivalent Examination as applicable. Mark Sheet is to be provided by the candidate even in case of failure in the examination.
3. Admit Card of Madhyamik or Equivalent Examination as proof of age.
4. Caste Certificate if available.
5. Candidates who are members of Self Help Group (Grade-I or Grade-II passed only on the date of notification) will submit certificates issued by BDO, Mirik
6. Candidates who are links workers or Dai under Mirik BPHC will submit certificate issued by BMOH, Mirik BPHC.
7. Candidates who stayed in govt. recognized homes any point of time will submit certificate issued by that home.
8. Documents for Marriage/Divorced/Widow etc. will be as follows
  - i. Certificates by government authority
  - ii. Certificates issued by Samaj in which the candidate belongs to.

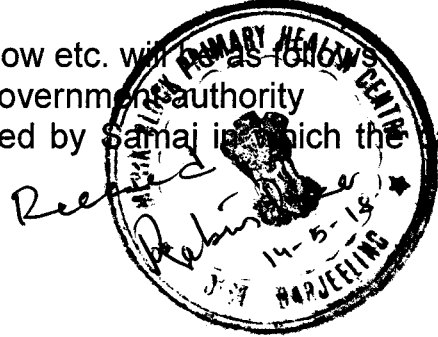
