NOTICE

This is to inform all concerned that the eligible list of candidate (subject to verification of original documents on the day of interview) and the ineligible list of candidates with reasons therein has been published in the Office of the, BDO Kurseong, BMOH Kurseong at Sukna BPHC, SDO Kurseong and in all the concerned Gram Panchayats and Health SubCentres under Kurseong Development Block. Call letters for the Interview have also been dispatched wherein the date of interview and other general instructions for the Candidates regarding the interview are mentioned in the call letter.

If any eligible candidates do not receive call letter by 4/10/18, they are requested to contact Office of the BDO, Kurseong, in person, for duplicate call letter which will be issued on production of any photo bearing identity card between 11am to 4pm on 05.10.2018, 06.10.2018 or 09.10.2018

It is also to inform that on the day of interview the candidate has to bring all the original documents, certificates and a set of self-attested photocopies of all documents that she had already submitted or had been asked to submit along with her ASHA application form. The photocopy of the mark sheet must have the both sides i.e. front page and back page. Verification of all documents will be done only on interview date. Every candidate must sign the verification details at the verification table before interview. The candidate will not be allowed to enter the interview room for interview unless she produces this Call letter, in original, for Interview.

There will be no provision of second interview date for absentee candidate and candidature of absentee candidates will be summarily rejected.

The candidate will not be allowed to bring any book, note, paper, bag and electronic devices including mobile phones into the interview room.

Any kind of malpractice or use of unfair means or canvassing by any candidate or any person for any candidate will lead to summarily rejection of candidature.

No request by candidate for change of date, time or place of interview will be entertained.

In case of such change, eligible candidates will be informed by the committee.

The issuance of the admit card is no guarantee or assurance of selection of ASHA.

The serial number of the call letter has no relevance regarding merit of the candidate.

Candidate has to report one hour before the time noted in the call letter.

90% weightage will be given from marks obtained by candidates Madhyamik or equivalent exam & 10% from interview. 90% weightage marks will be determined by ASHA selection committee and its decision in this matter is final.

In case any individual has any issues like claim or objection regarding the lists of Eligible and Not Eligible Candidates, He/She may approach to the B.D.O Office Kurseong with documentary proof/evidences relevant, on any working day till 6/10/18(11am-4pm). After 6/10/18 no such claim or objection will be entertained. Candidate/Applicant may submit claim or objection regarding the details of her candidature on any working day till 6/10/18(between 11am-4pm) with documentary proof/evidences in respect of her claim/objection. After 6/10/18 no such claim or objection will be entertained
