Sealed afresh tenders are hereby invited from the bonafide, reputed and experienced Press/ Printers for rates of printing of 'Draft Household List'& "Statutory Forms" in connection with draft publication relating to Socio-Economic & Caste Census'2011 for the Darjeeling district after cancellation of the NIT No. 01/II-1/SECC-2011 dated 27.12.2013.

- 1. The printer will have to print in both Devanagari (about 40% of total pages) and Bengali (about 60% of total pages) scripts. The number of pages to be printed will be approximately 12 lakhs pages.
- 2. The prospective tenderer, as a primary agency, should have satisfactorily completed at least one work of similar nature an amount of not less than Rs.3,00,000/-(Rupees three lakhs) under the State Government or its undertaking or the Central Government or its undertaking or any Statutory Body during the last 3(three) years from the date of issue of this Notice. The Tender should be accompanied with copies of tenderer's Pan Card, Professional Tax Receipt/Challan for the current year (2013-14), VAT Registration Certificate, Trade license. Proper Credential of Rs. 3, 00,000/- (Rupees Three lakhs only) in form of Completion Certificate/Payment Certificate of at least one work of similar nature for printing and supplying of forms etc. under the State Government or its undertaking or the Central Government or its undertaking or any Statutory Body during the last 3(three) years from the date of this notice.
- Payment of bill on its production will be made after successful execution of the work subject to availability of fund and no claim, whatsoever, will be entertained for any delay of payment. No escalation charge will be entertained against any N.I.T/ any accepted tender. Deduction of Income tax, V.A.T. (if required), etc. will be made at Source in accordance with the existing rules/orders.
- 4. Neither any Mobilization Advance nor any Secured Advance will be allowed.
- 5. Earnest money in the form of Demand Draft of Rs. 10,000=00 (Rs. Ten thousand) in favour of District Magistrate, Darjeeling, payable at Darjeeling, to be deposited with the tender.
- Refund of EMD: The Earnest Money of all unsuccessful Tenderers will be refunded through on receipt of application from the Tenderer from the Office of the District Magistrate, (Census Department), Darjeeling. The Earnest Money deposited by a successful Tenderer will be converted into Security deposit .No interest on Security Deposit will be paid by the tender accepting authority. The willing tenderers may remain present at the time of opening of Tender.
- 7. The District Magistrate, Darjeeling reserves the right to cancel or any/all tenders without showing of any reason whatsoever.
- 8. A tenderer's bid will be out rightly rejected with a forfeiture of his earnest money if it comes to the notice of the tender inviting authority during scrutiny that the credential or any other papers of a tenderer are fabricated, etc.
- 9. The Tender Inviting Authority may verify the original credential & other original documents of the lowest tender, if found necessary, before issuance of the work order and the work order will not be issued in favor of the tenderer if it is found on verification that such document submitted by him is either fabricated, etc,.
