Sealed Tender in prescribed Format is invited from bonafied Carrying Contractor for lifting and carrying Rice from the Godown of Food Corporation of India, Siliguri(Near NJP Station) to 6(six)different ICDS Projects of Siliguri Sub-Division like,1) Siliguri(U),2. Siliguri(U)-II,3. Matigara, 4. Naxalbri, 5. Khoribari and 6. Phansidewa ICDS Project.

Tender Forms will be **issued from 11:00 AM. of 08/12/2015 to 14/12/2015 up to 3:00PM** on production of valid & up to date VAT/IT/PT Certificate and Credentials of same nature of work from District ICDS Cell, Darjeeling, Hill Affairs Building and will have to be dropped in the BOX only to be kept in the chamber of Addl. District Magistrate(Dev), Darjeeling up to **2:30PM. of 21/12/2015**. Tenders will be opened on **21/12/2015 at 3:00PM** in the office chamber of the Addl. District Magistrate (Dev), Darjeeling

**Terms and Conditions:**

1. The Tender application should accompany the following documents :
  - i) **Earnest Money Rs. 50,000.00**(Rupees Fifty Thousand)only in the shape of DCR only in favour of the District Magistrate, Darjeeling,
  - ii) Up to date and valid VAT/PT/IT clearance Certificate and PAN Card(Xerox and attested) copy is to be enclosed along with the application,
  - iii) In case of Partnership or Company, valid documents are to be enclosed,
  - iv) If a Tenderer is a owner of a lorry/Lorries supported documents are to be enclosed
  - v) Certificate of previous experience if any, be enclosed
  - vi) Credentials of at least Rs. 3,00,000.00 only for same nature of work during last one year
  - vii) In support of Financial capacity, Bank Certificate or Bank Passbook is to be produced
  - viii) Rate of Carrying is to be offered per Quintal irrespective of distance against each ICDS Project including loading, unloading and all incidental charges at receiving and at delivery points,
  - ix) Rate should be quoted both in figures and words and it shall have to be specific and unconditional
2. Tender will be valid for one year and can be extended for a period of three months only, if both of the parties agree.
3. Selected Tenderer will have to execute an agreement bond with the District Authority.
4. Selected Tender will have to deposit **Security Money Rs. 50,000.00**(Rupees Fifty Thousand)only in the shape of DCR only in favour of the District Magistrate, Darjeeling
5. The Carrying Contractor will have to lift Rice in good condition sealed packets from FCI Godown and should have to deliver the same to the Storing Agent or any authorised person of the respective Child Development Project Officer.
6. For any loss on the due to the transporter's failure of any nature, the concerned transporter shall have to compensate the loss and in case of failure penal measure shall be imposed by the authority as per law,
7. No diversion of delivery order is allowed without prior permission from the District authority,
8. The Carrying Contractor should engage adequate & efficient staff and labourers for ensuring efficient handling the transportation work and for furnishing correct and up to date position/progress of work and account thereof,
9. All payments will be made by the District Administration or by the Child Development Project Officers on full satisfaction of the delivery work and against bills in triplicate supported by consignee copy and as per fund availability.
10. Delivery of Foodstuff should be made on the working days and within the working period only.
11. Failure of delivery within the specified period shall render the agreement liable for cancellation without any reference and the difference of charges will be deducted from the bills of the Carrying Contractor so failed.
12. Time is an essence of this contract

13. Prior to taking delivery from FCI, the sample shall have to be authenticated by the competent Official of the Dept. And the transporter shall be liable to deliver the same commodity as per sample drawn to the ICDS Project.
14. No transshipment is permissible unless situation warrants it unavoidable and in such event prior permission of authority is to be obtained in writing.
15. It shall be presumed that the Carrying Contractors have duly verified the location of the godowns of FCI & the storage points at the different Project godown.
16. On the sealed Envelope "Rate of Carrying Rice from FCI Godown" should be written clearly.
17. Tender Committee reserves the right to accept or reject any or all the rates without assigning any reason thereof.
18. Tender will be received up to 2:30 PM of 15.12.2015 and will be opened on that day at 3:00PM in the Chamber of Addl. District Magistrate (Dev), Darjeeling.
