3. Opening of the tender : 26.03.2016 after 3.00 P.M.
4. Form will be available at the Chamber of NDC, Nazarath Section, Darjeeling and may be downloaded from district website: www.darjeeling.gov.in.
5. For application, no need to deposit any fund for taking tender forms physically. But, during the submission of Tender forms with requisite papers Earnest Money should be submitted through a draft in favour of the District Magistrate & District Election Officer, Darjeeling as notified in earlier notice and Rs. 1000/- in cash per application has to be deposited at the Nazarath Section, Darjeeling before submission of the application i.e on or before **26.03.2016 (2.00 P.M)**.
6. There will be two bids (Technical Bid & Financial Bid). Bids should be submitted in separate envelopes.
7. The tenderers who have dropped their tender papers do not have to submit again.
