TERMS & CONDITION

01. Application for tender paper should be submitted to the chamber of the O/C, Infrastructure, (NDC) Darjeeling during office hours upto **01-00 P.M.** on or before **02-05-2017** along with valid P. Tax, VAT registration certificate & copy of the last return of VAT and Photocopy of the PAN card and copy of the last Income Tax return certificate, Photocopy of the enlistment certificate of the Panchayat Samity and credential (in the form of payment certificate and completion certificate of a single work) of the Engineer-in-Charge must be submitted in original and photography thereof.
02. Tender papers will be issued to the qualified contractors on **02-05-2017** after **3-00 P.M.** The Office of the District Magistrate, Darjeeling is not bound to issue tender papers to all the applicants. Decision of the undersigned regarding issue to tender papers is final.
03. Tender paper will have to be sent by hand and it should be reached to the office of the District Magistrate, Darjeeling within **02-00 P.M.** on **03-05-2017**. Tender paper received after the scheduled time and date will not be entertained. It will be opened on the same date and time at the Chamber of the Addl. District Magistrate (G), Darjeeling at **03-30 P.M.** The intending tenderers may remain present at the time of opening tender by the officers.
04. In case of running work, work order and upto date payment certificate etc. must be produced to the Engineer-in-Charge by the contractor.
The Original documents will be returned after scrutiny and the photocopy will be preserved by undersigned. Payment Certificate must be of last 03 years of similar type of works done by the contractor.
Partnership deed and other relevant papers (in case of registration Firm / Company) should be produced at the time of application if required.
All the tenderers have to submit along with their application the for this year if the work is reserved for that.
05. Time is the essence of contract. The successful contractor must complete the work within the time specified for completion. No extension of time will be allowed except in special case. If any contractor fails to complete the work within the stipulated time the work order issued in his favour will be cancelled without assigning any reason therefore. The undersigned may also proceed to get the balance work completed by any other means or through other contractors. The excess expenditure, if any, due such a step would be recoverable from the unpaid bills / security deposit of the tenderer. This is apart from any
