- Properly Indexed & self-attested documents & duly digitally signed of both the Technical Bid and the Financial Bid should be concurrently submitted in the Website mentioned above as per time schedule given below.
- Eligibility criteria for participation in tender :**
 - The prospective tenderer, as a primary agency, should have satisfactorily completed at least one work of similar nature for a magnitude of 40% of amount of amount put to tender under the State Government or its undertaking or the Central Government or its undertaking or any Statutory Body during the last 5 (five) years from the date of issue of this Notice.
 - Technical Bid Documents should be accompanied with copies of tenderer's Pan Card, Professionals Tax Receipt/Challan for the current year, VAT Registration Certificate (if any).
 - Registered Co-operative Societies of Unemployed Engineers and Diploma-holders in Engineering are required to furnish valid Bye-Law, Latest Audit Report, Valid Clearance Certificate from the Assistant Registrar of Co-operative Societies for the year 2015-16 along with other relevant supporting papers
 - The partnership firm is required to furnish copy of **Registered Partnership Deed.**
 - A Company shall furnish the **Article of Association and Memorandum.**
 - Bank Solvency certificate of 40% of the amount put to tender.
