NOTICE

In pursuance of undersigned's Order dtd. 30.10.2017 on the basis of analysis report of Assistant Director I&QC, F&S vide memo no. 1264/F&C dtd. 16.10.2017, 1265/F&C dtd. 16.10.2017 notice is, hereby, given for information of the bonafide industrial Organisation/ businessman that public auction of the below mentioned damaged stock of atta (annexed herewith) will be held on the date and venue as mentioned below. The interested party/ parties are invited to remain present at the time of auction. The stores can be inspected by the prospective eligible bidders at the godowns from where the delivery will be given as per annexed list. Security deposit of Rs. 50,000 in the form of Bank guarantee shall have to be deposited to the District Controller, F&S Darjeeling at Siliguri by the bidders which will be refunded after the auction. The minimum floor price (i.e, reserve price) of atta shall be Rs. 591.34 per quintal.

The successful bidder must deposit price for entire quantity of stock stated above before lifting the stock.

In such an event, an opportunity shall be given to the next highest quoting eligible bidder (i.e, 2nd highest bidder) to complete the bid provided he/she is prepared to accept the price offered by the highest bidder.
