  - i). The prospective tenderer, as a primary agency, should be a reputed Dealer or Distributor and should have completed the supply of similar nature of work for the last three year which should not be less than RS 10.00 Lakh.
  - (ii) Technical Bid Documents should be accompanied with copies of tenderer's Pan Card, Professionals Tax Receipt/Challan for the current year, IT Return Challan for the **financial year , 2016-17, 2017-18 , 2018-19** , GST Registration certificate, Trade license /S.S.I Registration (Part-II).
