- 1) For e-tendering, intending tenderer may download the tender document from the said website directly with the help of Digital Signature Certificate. Necessary Earnest money (where required) shall be deposited by the intending tenderers by way of Online/ NEFT/RTGS through ICICI Payment Gateway in favour of the District Magistrate, Darjeeling,
- 2) Properly Indexed & self-attested documents & duly digitally signed of both the Technical Bid and the Financial Bid should be concurrently submitted in the Website mentioned above as per time schedule given below.
- 3) **Eligibility criteria for participation in tender :**
  - i). The prospective tenderer, as a primary agency, should be a reputed Dealer or Distributor and should have completed the supply of similar nature of work for the last three year which should not be less than RS 5.00 Lakh.
  - (ii) Technical Bid Documents should be accompanied with copies of tenderer's Pan Card, Professionals Tax Receipt/Challan for the current year, IT Return Challan for the **financial year , 2016-17, 2017-18 , 2018-19** , GST Registration certificate, Trade license /S.S.I Registration (Part-II).

- 4) The Government approved supplying Organization viz Manjusha, Bangasree. Refugee Relief & Rehabilitation Directorate, Confed & Refugee Handicrafts are exempted from furnishing credentials required for the purpose.
- 5) Neither any Mobilization Advance nor any Secured Advance will be allowed.

- 14) The body bag should be extra strong with three carrying straps/ handle suitable for handling by 2,4, or 6 person. Handle should pass static lift tested to 200 kg capacity.
- 15) The body bag should have Zipper: Easy access centre zipper opening with dual locking zipper pulls allowing bags to open from either end. Zipper made of high quality reinforced stainless steel.

- 16)The body bag should have Maintain identification and "Chain of custody" integrity using serialized tamper resistant zipper pull seals , or disaster ID Kit, etc.
- 17)The body bag should be Made of special lining high density polythene reinforced material of ISI:7903:2017 quality IS certificate of the fabric manufacturer to be provided. Impervious abrasion resistant exterior material, impervious to blood , fats and other normal body fluids, 100% leak proof , sealed on sides ,Not biodegradable.
- 18)The body bag should be 100% water proof, UV stabilized. Shelf line in excess of 5 years
